**Biographical Sketch:**

Margaret Mary Strebel Hartman was born August 17, 1924, in Pendleton County, Kentucky, to Henry and Bertie Strebel. In 1915, the family moved to Newport and Margaret graduated from the Newport Public High School in 1942. She married Robert Hartman on November 19, 1948. She was the first vice president of the Southgate Women's Club in 1956 and served the local Girls Scouts in various leadership roles, including Scout Leader, registrar, and district chair. She researched and wrote extensively on the history of Northern Kentucky. She died on January 2, 1991, and is buried in Peach Grove Cemetery.
