Minutes

Julie Roesel Belton moved the July 16, 2024 meeting minutes be approved as submitted. Susan Kinsella seconded the motion, which passed unanimously.

Set Tax Rate

Susan Kinsella moved the Kenton County Public Library District certify that 10.3 cents per \$100 assessed valuation of Real Property be the rate levied for the year 2024 in accordance with the provisions of KRS 132.023 as amended by the 1979 Extraordinary Session and the 1990 Regular Session of the General Assembly. Julie Roesel Belton seconded the motion. A Roll Call Vote was taken. Voting YES: Maureen Hebert, Iliana Rosales-Figueroa, Julie Roesel Belton and Susan Kinsella. Voting NO: None. The motion carried. This is a reduction in the certified rate of 2023.

Julie Roesel Belton moved the Kenton County Public Library District certify that 17.33 cents per \$100 assessed valuation of Personal Property be the rate levied for the year 2024 in accordance with the provisions of KRS 132.023 as amended by the 1979 Extraordinary Session and the 1990 Regular Session of the General Assembly. Iliana Rosales-Figueroa seconded the motion. A Roll Call Vote was taken. Voting YES: Maureen Hebert, Iliana Rosales-Figueroa, Julie Roesel Belton and Susan Kinsella. Voting NO: None. The motion carried. This is the same as the certified rate of 2023 but less than the compensating rate of 17.51.

Julie Roesel Belton moved the Kenton County Public Library District certify that 6.0 cents per \$100 assessed valuation of Motor Vehicles and Watercraft is the rate to be levied for the calendar year of 2025. Susan Kinsella seconded the motion. A Roll Call Vote was taken. Voting YES: Maureen Hebert, Iliana Rosales-Figueroa, Julie Roesel Belton and Susan Kinsella. Voting NO: None. The motion carried.
